IN FY 2022 THE FRIENDSHIP CENTER WAS A SAFE HAVEN FOR 614 KNOWN AND 26 ANONYMOUS INDIVIDUALS OF DOMESTIC VIOLENCE, SEXUAL ASSAULT AND STALKING. STAFF PROVIDED 6,161 SERVICES TO THOSE 640 INDIVIDUALS. THESE SERVICES INCLUDE, BUT ARE NOT LIMITED TO, IN-PERSON CRISIS COUNSELING, SAFETY PLANNING, FINANCIAL EDUCATION, COURT AND HOSPITAL ACCOMPANIMENTS, AND ASSISTANCE WITH ORDERS OF PROTECTION. PEOPLE FLEEING DOMESTIC VIOLENCE SITUATIONS ARE OFTEN FORCED TO LEAVE MOST OF THEIR BELONGINGS BEHIND, SO WE ALSO PROVIDE ACCESS TO CLOTHING, FOOD, BABY NEEDS, FURNITURE, AND OTHER HOUSEHOLD ESSENTIALS.
